WHEREAS, Declarant desires to execute and record this Amendment to correct such error in Appendix A of the Declaration;

NOW THEREFORE, pursuant to the powers retained by the Declarant under the Declaration, the Declarant hereby declares as follows:

- 1. Appendix A of the Declaration is hereby replaced with Appendix A, attached hereto.
- 2. Declarant hereby subjects the property identified in Appendix A to the provisions of the Declaration and to the jurisdiction of the Association (as defined in the Declaration). The property identified in Appendix A shall be owned, held, transferred, sold, conveyed, used, occupied, mortgaged or otherwise encumbered subject to all of the terms, provisions, covenants and restrictions contained in the Declaration, which shall run with the title to the property identified in Appendix A, and shall be binding upon all persons having any right, title, or interest in such property, their respective legal representatives, successors, successors-in-title, and assigns.



COMMENCING at a PK Nail found for the southwest corner of said Tract II, same being on the north Right-of-Way (ROW) line of State Highway 71 (ROW Varies), also being on the east ROW line of Flat Rock Boulevard (100-foot ROW); THENCE, North 01°43'44" East, over and across said Tract II, a distance of 846.15 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the Northwest corner of a called 1.25 acre tract conveyed to Burnet County, and described in Document No. 202016120, O.P.R.B.C.T, same being in the south ROW line of Centurion Boulevard (80' ROW), and the POINT OF BEGINNING of the herein described tract; (Grid Coordinates: N=10,156,291.23, E=2,936,157.95)

1. Along said curve, having a radius of 150.00 feet, an arc length of 179.56 feet, and a chord bearing and distance of North 59°31'01" East, 169.03 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set at the end of said curve;

2. North 25°13'29" East, a distance of 149.88 feet to a 5/8-inch iron rod set with cap stamped "PELOTON BOUNDARY";

3. South 64°46'31" East, a distance of 87.95 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the beginning of a non-tangent curve to the left;

4. Along said curve, having a radius of 150.00 feet, an arc length of 270.04 feet, and a chord bearing and distance of South 35°10'34" East, 235.02 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the beginning of a reverse curve to the right;

5. Along said reverse curve, having a radius of 765.00 feet, an arc length of 239.58 feet, and a chord bearing and distance of South 77°46'43" East, 238.60 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set at the end of said reverse curve;

6. South 68°48'24" East, a distance of 243.38 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set on the west ROW of US Highway 281 (ROW Varies), same being the northeast corner of the herein described tract; THENCE, South 26°02'34" West, along said west ROW, a distance of 128.40 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for corner;

THENCE, over and across said Tract II, the following thirteen (13) courses and distances:

3. North 66°36'34" West, a distance of 95.30 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the beginning of a curve to the right;

4. Along said curve, having a radius of 944.00 feet, an arc length of 155.99 feet, and a chord bearing and distance of North 81°27'24" West, 155.82 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the end of said curve;

5. North 86°11'26" West, a distance of 142.04 feet to a set 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY";

6. South 48°48'34" West, a distance of 14.14 feet to a set 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY";

7. South 03°48'34" West, a distance of 67.69 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the beginning of a curve to the right;

8. Along said curve, having a radius of 640.00 feet, an arc length of 439.65 feet, and a chord bearing and distance of South 23°29'21" West, 431.05 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the end of said curve;

9. South 43°10'07" West, a distance of 1,226.93 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the beginning of a curve to the right;

10. Along said curve, having a radius of 1,000.00 feet, an arc length of 1,245.05 feet, and a chord bearing and distance of South 78°50'12" West, 1,166.18 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the end of said curve;

11. North 64°21'20" West, a distance of 310.83 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the beginning of a curve to the left;

12. Along said curve, having a radius of 460.00 feet, an arc length of 219.28 feet, and a chord bearing and distance of North 78°00'43" West, 217.21 feet to a 5/8-inch iron rod with cap stamped "PELOTON BOUNDARY" set for the end of said curve;

13. South 88°19'54" West, a distance of 219.17 feet to the POINT OF BEGINNING of the herein described tract, containing 70.3834 acres of land, more or less.
